

Nomination of Officers for ACSC Board

If you are interested in being considered for an ACSC Officer position you must apply for the position.

The process for consideration is the following:

- Meet the required qualifications
- Evaluate your skills as compared to the recommended qualifications.

- Online submission is recommended

The ACSC Board Officers are elected every 2 years at the Summer Workshop. The next election will be at the 2020 ACSC Summer Workshop when all 4 elected officers for the ACSC are up for election. All applications must be submitted online or postmarked by April 11, 2020 to be considered for office during the 2020 election cycle. The slate of officers will be presented at the ACSC Spring Safari Business Meeting on April 25, 2020, the election will be held on July 12, 2020.
