



**A.C.S.C MEETING MINUTES

I. CALL TO ORDER

ACSC Chairman Robin Morley called the Association of Carolina Shag Clubs meeting to order Saturday, April 30, 2022, at 10:00 am. Robin asked if there were any additions to the agenda. No additions were noted, therefore, a motion was made and seconded to accept the agenda as written. Robin introduced the A.C.S.C Officers, S.O.S Officers and SOS Board Members. 11. A.C.S.C SECRETARY'S REPORT

ACSC Secretary Becky Berry asked if there were any corrections or additions to the 2022 Mid-Winter minutes. There were three corrections. Two having been made and sent out in the last email sent before the meeting and Rodney Williams noted that the minutes showed CSRS instead of CSRA. Becky called for a motion to accept the minutes with corrections to be made. Motion to accept was made, followed by a second. Minutes were approved and will be recorded in the permanent records as written with those corrections made. Becky informed all the presidents that inside their packets was an updated Officers/Directors and Committee members list, the ACSC treasurer's report, and a flyer from Jim Hern with notes added from Robin Morley.

111. A.C.S.C TREASURER'S REPORT

ACSC Treasurer Cecil Martin presented the treasurer's report. Cecil noted that there were only 2 outstanding club dues at this time. Cecil stated that SOS card sales so far indicated a brighter future. Cecil noted that there was a donation of \$7,500.00 and that those donating wished to remain anonymous. Cecil stated that the balance as of March 31, 2022, after expenses, was \$20,835.24. Motion was made to accept the treasurer's report. The report was seconded and approved as presented. The Treasurer's report will be recorded as written.

IV. A.C.S.C CHAIRMAN'S REPORT

ACSC Chairman Robin Morley asked Garrett Humphries to come forward to speak on Jr. SOS. Garrett stated that Jr SOS was back after two years due to Covid restrictions. Garrett stated that they needed the help of the clubs and that this can be done through donations. Garrett stated that they give out scholarships each year to either one, two or three junior shaggers depending on applications submitted. Garrett said that shoe donations could be given to Betty Ladwig and if anyone had any questions to email him directly.

Robin called Al Guazzo, Nominating Chairman to come forward to speak on the ACSC Board elections. All four seats are up for re-election. Al stated that anyone interested needs to go to www.shagdance.com and look at the requirements and qualifications and if that feel that they meet both of these to submit an application. Al stated that the election will be held at the Fall ACSC Meeting in September.

Robin also reminded everyone that the ICON Committee would be holding a mini workshop after the Fall meeting for any presidents planning to nominate a candidate for ICON. Robin asked on behalf of Novelene Powell and Dot Smith, ICON Committee Chairmen, that you prepare any questions ahead of time and to remember that the deadline for submitting a name is November 1, 2022.

V. A.C.S.C VICE CHAIRMAN'S REPORT

Lisa welcomed everyone to the meeting. Lisa asked all first time presidents to stand up and be recognized. Lisa reminded each of them that they are leaders and that they are not only important to their clubs, but also to the ACSC/SOS. Lisa reminded everyone that ACSC was founded in 1984. Lisa recognized the founding members of the ACSC beginning with Ken Hudspath, Phil Sawyer and Ron Whisenant. Lisa also recognized Ann Sigmon for her many years (35) serving in Lake Hickory Shag Club.
