



**A.C.S.C MEETING MINUTES
2023 SPRING MID-WINTER ACSC MEETING – OD RESORT

I. CALL TO ORDER

ACSC Chairman Robin Morley called the Association of Carolina Shag Clubs meeting to order Saturday, January 15, 2023, at 10:00 am. Robin asked if there were any additions to the agenda. No additions were noted, therefore, a motion was made and seconded to accept the agenda as written. Robin introduced the A.C.S.C Officers, S.O.S Officers and SOS Board Members. 11. A.C.S.C SECRETARY'S REPORT

ACSC Secretary Becky Berry asked if there were any corrections or additions to the 2022 Fall Migration minutes. There being none, Becky called for a motion to accept the minutes as written. Motion to accept was made, followed by a second. Minutes were approved and will be recorded in the permanent records as written. Becky informed all the presidents that inside their packets was an updated Officers/Directors and Committee members list, the ACSC treasurer's report and a red voting slip for the three SOS Board seats up for election.

111. A.C.S.C TREASURER'S REPORT

ACSC Treasurer Cecil Martin presented the treasurer's report dated December 31, 2022. Cecil noted that the balance as of that date was \$4, 925.79. Cecil explained that that there could not be a guarantee of payment to the clubs this year. Cecil noted that the sale of SOS cards would determine if any reimbursement could be made. Cecil noted that club dues are due by January 31, 2023. After that date they will be considered late. Cecil Motion was made to accept the treasurer's report. The report was seconded and approved as presented. The Treasurer's report will be recorded as written.

IV. A.C.S.C CHAIRMAN'S REPORT

Candy reminded everyone that Lisa Caveny gave ideas at Fall Migration on how to move forward and keep communication open within the shag club and that she had invited to clubs to share some ideas that can be used in your clubs to keep the members interested. Speaking were Pat Hensley on Dancing with the Stars, John Carpenter on Shag Bingo, David Galloway on Photo Scavenger Hunts and Phil Long on Traveling Shoes. Candy also stated that inside your packets from her was an updated Past Presidents form for any club needing a Past Presidents Pin.

VI. S.O.S. CHAIRMAN'S REPORT

SOS Chairman, Ken Akin, stated that all clubs were well attended at Mid-Winter. Ken spoke of Ducks Night Life was close to being the old Ducks during Mid-Winter and that Ducks now has a new owner named Scott Carroll and he was very interested in what he could do to help with SOS.

Ken called Terry McCoy, SOS Parade Chairman to come forward regarding the parade in April. Terry stated that the theme for the parade was the Good Old Days and he was looking forward to this year's parade and the many ideas that the clubs participating would come up with. Terry stated that the deadline for submitting the applications was two weeks prior to the parade.

Ken asked Dwayne Baggott to come forward regarding the renovations to the SOS Company Store. Ken thanked Dwayne for heading up this renovation and all his hard work. Dwayne stated that the store has been completely renovated inside and that a grand opening would be held during Spring SOS. Dwayne stated that he had fourteen volunteers who worked with him to complete the renovations. Dwayne invited everyone to come by and see the new look inside the store.

Ken asked Ronnie Gregory, SOS Board Member, to come forward. Ken presented Ronnie with a plaque in appreciation for serving four years as the SOS Chairman. Ken thanked him for doing a super job as Chairman.

Ken turned the floor over to SOS President Ron Whisenant. Ron thanked Ronnie Gregory again for doing such a great job as SOS Chairman, Ron discussed card sales and stated that so far \$21,605.00 had been deposited in the bank. Ron also stated that

Ron stated that card sales are important along with members keeping their clubs going. Ron was asked the question how many cards do we need/have to sell to remain solvent. Ron stated that he did not have an exact number, but that it costs around \$40,000 for each SOS event. Ron said that the sale of 1500 cards equaled \$45,000. Other questions asked we regarding clubs checking for SOS cards, parking, and paying for floor space.
