



**A.C.S.C. MEETING MINUTES  
SOS SPRING SAFARI  
NORTH MYRTLE BEACH, SC  
SATURDAY, APRIL 16, 2011**

**I. CALL TO ORDER**

Chairman Ken Akin called the Association of Carolina Shag Clubs Spring Safari meeting to order at North Myrtle Beach, SC on Saturday, April 16<sup>th</sup> at 10:01 a.m. Ken introduced the ACSC Officers, SOS Board Members, and SOS Officers. Ken also introduced the SOS Photographers, Vicki and Paul Harrison, Webmaster Mary Gregory, and Past President Pins Chair, Glenda Brown.

**II. MINUTES FROM WINTER WORKSHOP**

Sonny asked if there were any additions or corrections to the minutes. Motion to accept the minutes made and seconded. Minutes approved.

**III. TREASURER'S REPORT**

Allen noted that there are 2 Treasurer Reports. The SOS Charitable Foundation had a balance as of 1/1/2010 of \$14,409.58, Total Income of \$38,963.12, Total Donations of \$26,685.00 leaving a balance as of 12/31/2010 of \$26,687.70. A golf cart street vehicle for the NMB Safety Department valued at \$8,400.00 was donated.

The ACSC Treasurer Report had a balance as of 1/1/2011 of \$18,639.35, Net Receipts of \$20,326.30, Total Expense of \$14,006.20 leaving a balance as of 3/31/2011 of \$24,909.45. There were no questions and a motion to accept the Treasurer Reports was made and seconded.

#### **IV. 2011 SHAGGING ICON AWARDS**

Ken presented the 2011 ICON AWARDS to the following recipients: **Tom Armstrong (R & B Shag Club), Richard McElroy (ShagAtlanta), Robin Morley (Sandy Beach), Rodney Williams (CSRA), and Glenna Watts (Charlotte Shag Club).**

#### **V. A.C.S.C. CHAIRMAN'S REPORT**

Ken asked for intentions for the 2013 workshops. Fayetteville Area Shag Association (District 1) made their intent to bid on the 2013 Winter Workshop. ShagAtlanta (District 4) made their intention to bid on the 2013 Summer Workshop. Ken told them to be prepared to make presentations at the Summer Workshop. Ken noted other clubs from District 1 & 4 can bid on these workshops. Ken noted that the 2011 Summer Workshop will be held in Augusta July 8-10 and will be hosted by CSRA.

Ken presented a plaque to Terri Wall for her 18 years serving as the Past President Pin Chairman.

#### **VII. S.O.S. CHAIRMAN'S REPORT**

Helen reported that on Wednesday the SOS Board fed the city workers to show our appreciation for what they do for us.

Ronnie Gregory, Chairman of the Website Committee wanted to update you on the website and ask for your input. Ronnie introduced the members of the committee; Judy Vick and Mary Gregory.

Helen noted that a lot of activity has gone on at the Company Store and that Judy Vick manages it. Judy has Linda Solomon and Ann Hammond helping her out.

Chris Jestes gave an update on the Enhancement Committee. Chris noted that all monies after expenses go to charity. A portion goes to a local charity; Caring for Kids and the rest goes to the SOS Charitable Foundation. Chris asked that we help keep North Myrtle Beach clean as we are their guest.

Chris noted that next year Fun Monday will be 15 years old and next year a special celebration will be held.

AnnE Henry reported that on Saturday, September 24<sup>th</sup> at 1:00 p.m. we will set a record for most people dancing in the street. We will need a minimum of 251 participants to break the record. North Myrtle Beach has given us the okay to close off Main Street. The Enhancement Committee has agreed to serve as security. A donation charge of \$5.00 will be for each entry which will go to charity (SOS Charitable Foundation). There will be a specific set of guidelines that will need to be followed and they are being worked out as to what they are. AnnE said that to break the record you must dance for 5 minutes non-stop. AnnE said that details are still being worked out and as soon as they are known she will email the shag clubs. Ron thanked everyone for their cards and well wishes for Peggy. Ron reported that our SOS deposits to date are \$150,887.00 for card sales that includes Mid Winter sales. Shag club sales to date are \$92,670.00. Ron stated that at the Summer Workshop he will have a much more complete report on card sales with a comparison on where we were last year vs. this year. Ron reported that the first weekend SOS was a little off. He stated this could be due to SOS being 2 weeks earlier than usual, Easter and pay the I.R.S. taxes. Ron stated that this week North Myrtle Beach was at capacity.

Ron stated that you received in your packet today a hole sponsor form for the Hall of Fame Foundation and S.O.S. Al Cain Golf Classic. Ron asked each shag club to consider sponsoring a hole for \$100.00. The Hall of Fame Foundation is a "friends helping friends" organization.
